## **Old Business:**

#### **Rental Inspection Ordinance:**

Discussion between Planning Commission and guests representing area landlords took place. Kelly asked what direction if any has been received from the Village Council as to what they would like the Planning Commission to do in regards to an ordinance. It was noted that at a prior meeting the Village Council made request for the Planning Commission to review and make recommendation if ordinance is needed. Bouvy made note that what good is another ordinance if ordinances on the books at the present time are not being enforced. Elbers reported that he had talked to a member from Buena Vista about their Rental Ordinance and reported his findings. Jeff Fountain - Landlord suggested that a hand-out for renters be compiled by the landlords with information and contact phone numbers to be presented when renters sign their lease. Hill pointed out that the Michigan Legislature Act 207 of 1941 covered everything that we would want to include in a Rental Inspection Ordinance. Elbers stated that he felt that some kind of ordinance was needed to protect the Reese renters.

Motion by Rohloff and 2<sup>nd</sup> by Bang to make a recommendation to the Village Council that in place of Rental Inspection Ordinance for the Village of Reese, the Village use Michigan Legislature Act 207 of 1941 that already covers inspections. Motion carried unanimously.
